Moreover, Parliaments must serve as the primary platform for robust and informed engagements on disaster management strategies and to ensure that our laws and policies are adaptive and resilient.

The role of the legislature extends beyond the realm of legislation. It is essential for the Parliaments to actively facilitate partnerships among key stakeholders, including governments, civil society, the private sector and international organisations, in order to contribute to a comprehensive approach to disaster risk reduction.

**Ladies and Gentlemen,**

Disasters know no border, which means that countries in the region need to adopt a transboundary approach in their perspectives and responses. This includes sharing knowledge, best practices, and resources. The

SADC region is a community of nations, and it is through unity, solidarity, and collaboration that we can effectively address the challenges posed by climate change and disasters.

Accordingly, it is imperative for the SADC Parliamentary Forum and National Parliaments to advocate for the implementation of both the SADC regional and global disaster risk reduction and recovery planning frameworks. These frameworks not only provide comprehensive strategies for addressing the challenges posed by natural disasters but also offer guidelines for coordinating efforts among SADC member states and international partners. Through this approach, Parliamentarians will make a significant contribution to reducing the impact of disasters and ensuring long-term recovery and development, particularly in the context of the escalating challenges associated with climate change.

By giving top priority to advocating for the integration of disaster risk reduction and climate adaptation into all aspects of national development plans, Parliaments will contribute to building resilience and ensuring that our investments in infrastructure, education, and healthcare are guided by risk considerations and are sustainable.

Due to the constant threat of extreme weather events, the Government of Mauritius has been swift to enact the National Disaster Risk Reduction and Management Act in 2016 which established a statutory Council and

a Strategic Framework to deal with mitigating the risks of disasters and to prepare for recovery. Our National Policy on Disaster Risk Reduction and Management (2020-2030) adopts a modern approach that is community-centered and tailor-made to empower individuals to build resilience to surmount the adverse consequences of natural disasters. I am certain that the presenters from the relevant national authorities will be able to give more details on the strategies and guidelines which are adopted by Mauritius.

Accordingly, I am confident that the theme of this Plenary Assembly will enlighten SADC Parliamentarians on the significance of early preparations in disaster management and will engage in lively and productive deliberations on the subject. Without doubt, the Resolutions of this Plenary Assembly will contribute to making the SADC region a safer place that is conscious of the need for climate change governance as well as disaster preparedness.

I am also alive to the fact that this Plenary Assembly will be coinciding with the International Day for the Elimination of violence against Women which will be commemorated on this 25<sup>th</sup> November 2023. I am pleased to share that my Government adopts a zero tolerance approach with respect to all forms of gender-based violence. In this respect, the theme of this Plenary Assembly also resonates with the



protection of women since it is well known that climate disasters tend to aggravate the circumstances and vulnerabilities of women who may lose shelter, their possessions or even their employment pursuant to extreme weather events around the world. Without doubt, there is no place for violence against women in the 21<sup>st</sup> century and it is positive to note that this august Assembly will add further momentum to the elimination of violence against women in Southern Africa and beyond.

In conclusion, I wish to reiterate that the theme of this 54th Plenary Assembly challenges all of us to rise to the occasion and demonstrate our commitment to the well-being of our people and the sustainable development of our region. It calls upon us to be proactive and forward-thinking in our legislative efforts, putting disaster risk reduction and recovery planning at the heart of our parliamentary agendas.

By working together collaboratively, Parliaments can make a significant difference and contribute to the creation of a more resilient, prosperous, and sustainable SADC region.

I have now the honour to declare the 54<sup>th</sup> Plenary Assembly Session of the SADC Parliamentary Forum officially open and wish you all fruitful deliberations.
