# HOSTING THE PLENARY ASSEMBLY FOR THE $57^{TH}$ ASSEMBLY BY THE PARLIAMENT OF ZIMBABWE

We are honoured and elated to be here.

I must also add that this is the 6<sup>th</sup> time that the Parliament of Zimbabwe has physically hosted the Plenary Assembly of the Forum, making Zimbabwe one of the most visited countries by SADC-PF delegations.

We are thrilled to be welcomed back to this hospitable country which has given much more to the Forum than we could give back.

Allow me Director of ceremonies to underscore that this Assembly meets at a time when inter-parliamentary cooperation and diplomacy around the world is being upheld as a means for peaceful conflict resolution. With the month of June being the month when the Forum celebrates the International Day of Parliamentarism on the 30<sup>th</sup>, it is opportune that this august Assembly meets in the lead-up to the commemoration in view of activating the necessary momentum through responsive resolutions and decisions.

It is also an honour to be meeting delegates of the Forum in the vicinity of Victoria Falls in the Republic of Zimbabwe, a country which stands as an illustrious example for its diversity and its unique resilience. The country has moved from its traditional economic pillars to embrace innovation and smart governance, examples include climate-smart agriculture with the growing of drought-resistant crops, strategic partnerships to promote the mining industry, as well as the opening of new opportunities for manufacturing businesses. The Government is also clamping down on tax avoidance and erosion which is fundamental to promote sound public financial management in line with the SADC Model Law on PFM.

In the fight against HIV and AIDS, Zimbabwe has pioneered innovative domestic financing through the National AIDS Trust Fund, popularly known as the AIDS Levy, a model that has inspired many across the continent. This homegrown solution has enabled the country to scale up treatment, prevention, and support services. It exemplifies what we in the Forum advocate for; sustainable, locally led financing for health and social development.

I am informed that this year, the country is expecting a GDP growth of 6% which is much higher than the average for the region.

Furthermore, being a country with one of the highest adult literary rates in the region, Zimbabwe is well-known for its intellectual human resource/workforce which generate unparalleled ingenuity and thought leadership. The visionary leadership of citizens of Zimbabwe has over time, greatly assisted the African continent to prosper.

The Parliament of Zimbabwe is presided by one of the greatest thought leaders of our time, Hon. Speaker Advocate Jacob Francis Nzwidamilimo Mudenda, who has for several years been the Chairperson of the Legal Sub-Committee of the Forum as well as represented the SADC-PF as the Head of the Lobby Mission to transform the Forum to a Regional Parliament. Hon. Mudenda is a prominent figure within the Executive Committee of the Forum and, as a thought leader, he has selflessly put his vast wisdom and discernment at the service of the SADC-PF. Earning him the title of Dean.

Moreover, Zimbabwe has provided exemplary leadership through its Members of Parliament. We remember with pride the service of Senator Monica Mutsvangwa, who not only served as Vice President of the Forum, but also as Treasurer, bringing both strategic vision and financial acumen to our institution. #### All in all:

- (i) 13 of the 15 Parliaments are in attendance.
- Out of 13 delegations: 10 are led by Speakers and 3 by Deputy Speakers, and of these, 6 Parliaments are led by female Presiding Officers (46%), 7 are led by male Presiding Officers (54%).
- (iii) Regarding political diversity, 35 Substantive Members are from ruling parties, 14 are from opposition parties, and 9 are not affiliated with any political party. These include independent Members, traditional leaders (chiefs), or representatives from systems without political parties, such as Eswatini.
